Option 2 – Payment in Full upon Receipt of the February Billing Statement

The student/parent/guardian/payer will receive a billing statement in early February. The account balance is due in full by February 25. If full payment is not received by March 3, a late fee of \$20 will be charged to the account, and a three-month payment plan will automatically be set up which includes a 3% set-up fee.

Option 3 – Payment Plan

The payment plan for **Session II will divide the tuition into three monthly installments February – April.** There is a 3% set-up fee based on the total tuition and is included in the payment plan total. A late fee of \$20 will be charged to your account EACH MONTH your payment is received after the date indicated on the statement.

Option 4 – Automatic Credit/Debit Card Payment Plan

There is a 3% set-up fee based on the total tuition and is included in the payment plan total. The student/parent/guardian will receive by mail, a billing statement each month. This billing statement is for your reference only; the SCAA office will process the payments as described above. Your account will not incur late fees as long as the office is supplied with current and active credit card information.
